



Participant Liability and Media Release Form Youth Sports Extravaganza – Give back Games

Liability Release

Ventura County YMCA nor their parent Organizations, nor California Lutheran University, nor any volunteer supporting the event may be held liable in any way for any occurrence in connection with my / our participation in the Youth Sports Extravaganza – Give Back Games on March 24, 2018 that may result in injury, death or other damages to me or my Guardians or my Family, heirs, or assigns in consideration of being allowed to participate in this event.

I hereby agree to indemnify, defend and hold harmless Kiwanis, the YMCA and CLU and other event Producers, their employees, directors, affiliates, officers, agents ,event coordinators and volunteers from any and all losses, injuries, damages, liabilities, claims or expenses of any kind, including, without limitation, reasonable attorney’s fees incurred in connection with, arising out of or relating to the Event , and further to save and hold harmless said event and persons from any claim by me, or my family, estate, heirs or assigns arising from my / our participation in this event.

I further state that I am of lawful age and legally competent to sign this affirmation and release, or that I have acquired written consent from my parents or guardians, that I understand the terms herein are contractual and not a mere recital, and that I have signed this document after fully understanding the terms of this contract, of my own free will.

It is my intention by this instrument to exempt and release the Parties named above from all liability whatsoever for personal injury, property damage or wrongful death arising out of the course of my / our participation in this event.
